PRIZE DRAW – EVERTON VS COVENTRY MATCHDAY EXPERIENCE

TERMS & CONDITIONS

Introduction

1. These terms and conditions (“**Terms**”) form the basis of the offer to participate in the CMC Invest Everton vs Coventry Matchday Experience (“**the Prize Draw**”).
2. Taking part in this Prize Draw constitutes acceptance of these Terms. CMC Markets Investments Limited (company registration number 12816952) (“**CMC Invest**”) is the provider of this Prize Draw. CMC Invest reserves the right to vary or cancel these Terms where reasonably necessary to do so, subject to applicable law.

Offer Period

3. The Prize Draw is open on 13 August 2026 and will close on 9 October 2026 in accordance with the [Transfer Bonus Terms](#) (“**Promotion Period**”).

Conditions of Eligibility

4. The Prize Draw is open to UK residents aged 18 years or older (“**Eligible Entrant**”).
5. Employees of CMC Invest or any other company within its group are not eligible to enter this Prize Draw.
6. To be eligible to be selected as a Winner (as defined below), an Eligible Entrant must, during the Promotion Period, initiate an Eligible Transfer in accordance with the [Transfer Bonus Terms](#). An Eligible Entrant who satisfies clause 6 will automatically receive one entry into the Prize Draw. No separate action is required to enter.
7. Only one entry is permitted per Eligible Entrant, irrespective of the number or value of eligible transfers initiated during the Promotion Period.
8. CMC Invest may disqualify an entrant whose eligible transfer does not satisfy the Transfer Bonus Terms or who acts fraudulently.

The Prize Draw & Prize

9. Following the expiry of the Promotion Period, all Eligible Entrants will be entered into a random draw, and two (2) winners will be selected by CMC Invest at random from all valid eligible entries by an independently supervised random selection process or by a verifiable random computer process (“**Winners**”) to receive:
 - a. one (1) Winner will receive two (2) passes to the enclosure for the Everton vs Coventry match, on 7th November 2026 at the Hill Dickinson Stadium.
 - b. one (1) Winner will receive two (2) general admission tickets for the Everton vs Coventry match, 7th November 2026 at the Hill Dickinson Stadium.(the “**Prize**”).
10. The Prize is subject to any applicable ticketing terms and conditions, stadium regulations and other policies imposed by Everton Football Club from time to time. The Winners are responsible for complying with such terms, conditions and regulations. CMC Invest accepts no responsibility or liability for any act or omission of Everton Football Club or for any changes to, suspension or withdrawal of the Prize resulting from the application of such terms, conditions or regulations.
11. CMC Invest’s decision in relation to any aspect of the Prize Draw will be final and binding on every

Eligible Entrant.

12. Winners will be notified by email on or before 23rd October 2026 and must claim their Prize within five (5) calendar days of notification. If a Winner fails to claim their Prize within five (5) calendar days of notification, then CMC Invest reserves the right to select a reserve Winner in accordance with the original random draw process.
13. The Prize will be issued in the name of the Winner, and the Winner may not transfer or assign the Prize, including to friends or family members.
14. The Winner may be asked (but is not obliged) to participate in reasonable publicity, subject to the Winner's consent where required.
15. CMC Invest reserves the right to verify the eligibility of any entrant or Winner, including by requesting proof of identity, age or residency. Failure to provide any information reasonably requested within the time specified may result in disqualification and the selection of an alternative Winner.
16. CMC Invest reserves the right to substitute the Prize with a prize of equal or greater value, where reasonably practicable, if the Prize becomes unavailable due to circumstances beyond CMC Invests' reasonable control, including where it is cancelled, postponed, withdrawn or amended by Everton Football Club or any other third party.
17. This Prize Draw is non-exchangeable, non-transferable, and is not redeemable for other prizes.

Legal

18. CMC Invest will be collecting personal information from all participants to facilitate the Prize Draw. If the information requested by CMC Invest is not provided, the participant will not be eligible to participate in the Prize Draw. By taking part in this Prize Draw, personal information of participants will be processed for the purposes of administering the Prize Draw in accordance with CMC Invests' Privacy Policy. CMC Invest will share the personal information of Winners with Everton Football Club solely for the purpose of verifying eligibility and administering the Prize. Any information collected from participants in the Prize Draw is subject to CMC Invests' Privacy Policy and will be handled in accordance with the applicable laws of England & Wales.
19. Subject to applicable data protection law, the surname and county of the Winners may be made available on request. Any request must be made within 30 days of the closing date by contacting ticketing@cmcmarkets.com. Winners may object to or limit disclosure where they have legitimate grounds.
20. If for any reason the Prize Draw cannot be run as planned due to circumstances including, but not limited to, infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the reasonable control of CMC Invest which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Prize Draw, CMC Invest reserves the right (subject to applicable law) to cancel, terminate, modify or suspend the Prize Draw and, where appropriate, to select Winners from eligible entries received prior to the relevant event.
21. CMC Invest also reserves the right to disqualify any person who tampers with the entry process, acts fraudulently or in breach of these Terms, or otherwise seeks to undermine the legitimate

operation of the Prize Draw.

These Terms and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with them or the Prize Draw shall be governed by and construed in accordance with the laws of England and Wales. The courts of England and Wales shall have exclusive jurisdiction to settle any such dispute or claim.
